- 1. AGM 2018 Minutes: Approved no matters arising, proposed by Cllr Cooper, seconded Anthony Kay.
- 2. Presentation of the Chair's Report for 2018:

Key issues covered:

- Pollution Levels: BRA project to measure pollution across Belsize with results in a year's time.
- · Setting up of Belsize Society as CIO.

Questions and comments on the Chair's Report included:

- 100 Avenue Road: CMP being managed by a steering committee in which the BRA is participating. This covers use of A41 for lorry movements.
- CS11: Westminster's successful Judicial Review stopping changes in Swiss Cottage gyratory.
- Issues raised by multiple developments near Eton Avenue.
- · Cyclists and scooter users riding on pavements to be raised with Camden and TfL.
- Requests for updates in Newsletter about various developments, previous and forthcoming.
- Presentation of 2018 Accounts: Treasurer reported that donations from Camden's filming unit enabled BRA to make additional donations; the deposit account would be closed pending better terms

Accounts 2018 approved nem.con, proposed by Jonquil Stewart, seconded by Maria Higson.

4. The Chair introduced a motion asking members to dissolve the BRA and to continue its activities through the CIO Belsize Society.

A resolution to transfer finances, archives, website and assets from the Belsize Residents Association to the Belsize Society was proposed by Ken Ellis and seconded by Barrie Buzan, approved by 65 members with two abstentions.

 - Members advised the Committee about potential help/support in setting up the Society.
