BRA business

- 1. BRA status: Charity Commission now reviewing February applications. BRA submission was made in March so maybe a decision in a few weeks.
- 2. Engaging more volunteers: discussion for supporting current volunteer groups covering newsletter deliverers, noticeboard monitors and event helpers. Additional volunteers to be sought via August Newsletter and email to members.
 - NB: Data Protection Policy to be adjusted to include 'lead volunteers'.
- 3. CIL Community Pollution Monitoring Project: BRA should know by September whether it can contribute person power for start of project next January. Camden will provide training. Agree to use the August Newsletter to alert members and recruit monitoring volunteers
- 4. Camden's Transport Strategy Workshop on 4th July: BRA suggest introducing i. Measures to encourage kids to walk/cycle to school to reduce congestion and
 - pollution impact of school run.

 ii. Improving road safety measures for pedestrians, such as anti-social cycling and scooter speeding, especially on pavements.
- 5. Camden public meeting re Local Transport Issues on 18th July: BRA issues include i. Phasing of lights at Waitrose/Finchley Road crossing, which allows insufficient time for pedestrians to cross and ensuring same problem doesn't arise with new Swiss Cottage gyratory system. Also improve accessibility to underpasses at Swiss Cottage. ii. Given changes and destruction/construction at Swiss Cottage, seek assurance that planning for any related disruption and concurrent one-off disruptions (strikes, replacement buses, etc.) is sufficient for buses to run in timely manner.
- Secure Cycle Parking units in Upper Park Road (consultation ends 27.06.18): BRA
 preference is for hoop style units and will follow local preference for siting. SP to
 respond.
