- 2. Planning application numbers have fallen dramatically compared to last year. Two applications for retrospective consent in Steele's Road and Belsize Place need inspection prior to comment.
- 3. 100 Avenue Road: new complex application will need a thorough review to understand proposal. The application for the change in facing materials has gone to appeal and the decision should be issued soon. Essential Living seem determined to pursue development.
- 4. England's Lane launderette (TS): application to change use refused. Should it be listed as Asset of Community Value as is launderette in Belsize Village?
- 5. 02 Centre redevelopment application (TS). BelSoc report. (c/f to June).
- 6. CAAC (Conservation Area Advisory Committee): formerly recognised by Council as statutory relationship body and handles appointments. Noted that historically, BelSoc and CAAC worked together on some strategic areas such as Conservation Area Statement research but separately on individual planning applications.
