Update: further drainage surveys and vegetation clearance

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can work within the guidelines are operational. All sites will remain under constant review.

Drainage surveys from 9 November

We recently wrote to you regarding drainage surveys being carried out in your area. We will be carrying out further surveys on Eton Road, Fellows Road, Primrose Hill Road, Provost Road and Steele's Road from 9 to 12 November.

Each survey is planned to take place in one overnight shift from 9pm to 6am the following morning to minimise disruption to the road network. We will use a camera to investigate the condition of the drainage and may need to flush the drainage using a high-pressure water jet.

Temporary changes while we carry out the surveys

On 9 November, lane closures will be in place overnight on Adelaide Road near the junction with Lower Merton and Elsworthy Rise. Parking bay suspensions will be in place on Adelaide Road and bus stop M (Elsworthy Rise) and U (Primrose Hill Road) will be suspended overnight.

On 10 November, lane closures will be in place on Primrose Hill Road and the junction of Fellows Road with no left turn. Parking bay suspensions and bus stop N (Primrose Hill Road) and S (Primrose Hill Road) will be suspended overnight.

On 11 November, a lane closure will be in place overnight on Steele's Road and at the junction of Fellows Road and Eton Road. Parking bay suspensions will be in place overnight.

Duration of works

Utility surveys will take place from 9 to 12 November

The surveys will take place overnight from 9pm to 6am the following morning

Vegetation and tree removal will take place from mid-November for up to six weeks

We may be on site for an hour before the start and/or end of each shift

What to expect

Temporary traffic management will be in place overnight

A water tanker will be present during the surveys in case we need to flush the drainage

We will remove vegetation and trees from within our site boundary

Measures will be in place to reduce any disruption to residents

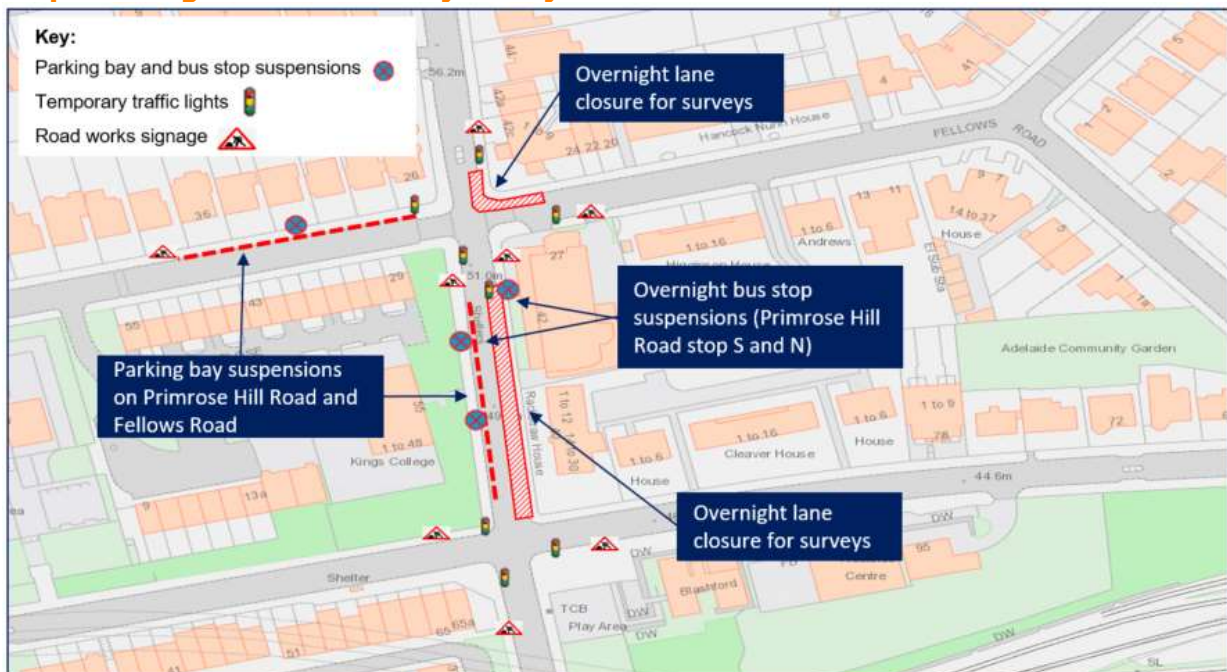
