1. **Apologies for absence**: Deborah Buzan, Gordon Curtis, Pat Holden

2. Minutes of last meeting

- a. July minutes (in amended form) were agreed.
- b. Matters arising from July minutes not covered elsewhere: none

3. Finance

- a. Accounts for June, July and August 2014: Agreed subject to one minor amendment to August accounts which will be re-circulated

5. Planning

- a. Planning applications: June, July, August 2014: No report
- b. 100 Avenue Road: (i) Deputation request for planning meeting on 11 September 2014: PV reported that the meeting will commence at 6.30pm. He will write a written submission (deputation request) about why we want to speak at the meeting which will be in the hands of the Chair of the meeting. PV will circulate a draft for comments by the Committee. (ii) Funding for the study commissioned by Save Swiss Cottage campaign can now be released by the Treasurer.
- c. Member concerns about studios and outbuildings in back gardens: After discussion, it seems that there is more than minimal concern about oversized outbuildings particularly in gardens that already contain extensions.
 - ACTION: Gordon Curtis will be asked to keep an eye out for planning applications for outbuildings and to bring them to the Committee's attention.
