2. Minutes of last meeting

- a. Agree November minutes: Agreed as circulated.
- b. Matters arising from November minutes not covered elsewhere: JF had not had time to contact Camden's HS2 group to urge that Glenda Jackson MP should be invited to join but will do so as soon as she is able.

- a. Accounts for November 2014: Approved as circulated

8. Web site

- a. Development of new web site: for update: AS will progress asap.
- b. Payments for website in 2014: There is doubt about who is the recipient of £18 odd which NH believed was going monthly to the website host but may upon analysis not be sent to them. It seems to be going to a telecoms provider for broadband or home phone services.

ACTION: NH to stop the Direct Debit as a matter of priority, and inform the broadband provider. **NH** will ask the bank for a copy of the DD mandate to check how this has come about, whether by error or by fraud.
